# Camper Registration 2024

## Deposits:

- For each individual registration, a \$75 deposit must be paid immediately. This can be done by credit card or Visa Debit.

## Cancellations:

- For cancellations made **on or before** May 15<sup>th</sup>, all fees are refundable minus a \$30+tax cancellation fee per person .
- For cancellations made **after** May 15<sup>th</sup>, the deposit of \$75 per registration is non-refundable.
- For cancellations made after **June 15<sup>th</sup>**, all program fees must be paid in full and become non-refundable unless a written explanation from a doctor is received, in which case only the deposit is non-refundable.

## Refunds:

- Programs that do not receive a minimum number of registrations will be cancelled and fees paid will be fully refunded.
- In the case of withdrawal during the program on a physician's order, a refund will be given based on the timing of the withdrawal.
- No refund will be made for dismissals due to disciplinary action, late arrivals, or early departures.

## Payment

### Payment Requirements

Balances for Kids Camp registrations must be paid in full by **June 15<sup>th</sup>**. Failure to do so may result in the child's registration being removed. Camp Kahquah reserves the right to add late charges (an additional 1% of the remaining balance per week) as they incur.

If you are receiving assistance from a Church or other organization outside of the Camp Kahquah Financial Assistance program, it must be reported to [office@campkahquah.com](mailto:office@campkahquah.com) as soon as possible so we can ensure the balance is paid.

### Payment Options

**I will pay in full by credit card now** – The balance will be completely charged and paid to Camp Kahquah immediately.

**I will pay the deposit now and manually make payments on my account myself** – You can login and view your account at any time. You can also make payments on your account at your convenience.

**I will pay the deposit now and would like 3 automatic installments taken off my credit card on March 15<sup>th</sup>, April 15<sup>th</sup> and May 15<sup>th</sup>** – On these dates, we will charge the installment amount to the credit card provided. To determine the installment amount, we will divide your balance into 2 equal payments and apply the charge on each date.

**I will pay the deposit online now and the remainder I will send to Camp Kahquah using a cheque(s)** – You may mail post-dated cheques for the remaining balance. Cheques must be received by **June 15<sup>th</sup>**. Please make cheques payable to Camp Kahquah and send them to:

## Waiver

**By signing below, I acknowledge and understand:**

- My child is in good physical and emotional health, and amenable to normal camp authority.
- The Camp Director reserves the right to dismiss a camper who is, in their opinion, a hazard to the safety and rights of others or appears to them to have rejected reasonable camp controls.
- I, as a parent or guardian, have legal custody of the child applying to Camp Kahquah and if applicable have informed the Camp of any conditions of custody. The signature on the registration form signifies that both parents/guardians are in agreement with the conditions of enrollment.
- Care is taken for the safety and good health of campers, but in the event of an accident or sickness, the Be In Christ Church of Canada, Camp Kahquah, including the Board of Directors and staff, and the owners and employees of the facilities outside of the campgrounds are hereby released from any liability. Each camper must be covered by Provincial Health Insurance or equivalent medical insurance. In the event that a camper requires special medication, X-ray, or treatment beyond that which is available at Camp Kahquah, the parents/guardians will be notified immediately and will be charged with the additional expense of transportation and special care.
- In the event of an emergency, I hereby give permission to the physician selected by the Camp Director to hospitalize, secure treatment for, and to order injection, anaesthesia, or surgery for my child as names above.
- That alcohol tobacco, vaping, marijuana, and illegal drug use is strictly prohibited on the property of Camp Kahquah. Camp Kahquah has the right to dismiss anyone who does not follow this policy.
- Permission is given for Camp Kahquah to use any image or likeness of my child for their promotional material, unless otherwise stated on the camper's registration.

- Camp Kahquah requires that campers who have potentially life-threatening conditions, such as peanut allergies, be able to manage their exposure to those substances, provide two sets of medication, and be familiar with its use. In the case of withdrawal during the camp on a physician's order, a refund will be given based on the timing of the withdrawal.
- The deposit of \$75 per week, per person, is non-refundable for cancellations made after **May 15<sup>th</sup>**. For cancellations made on or before **May 15<sup>th</sup>**, a refund will be issued minus a \$30+tax cancelation fee. For cancellations made after **June 15<sup>th</sup>**, all program fees must be paid in full and become non-refundable, unless written explanation from a doctor late arrivals, or early departures. is received, in which case only the deposit is non-refundable. No refund will be made for dismissals due to disciplinary action,
- All busing requests are considered final as of May 15<sup>th</sup>. If a cancellation is required prior to this date, a refund will be issues. After this date, busing fees become non-refundable.
- Programs that do not receive a minimum number of registrations will be cancelled and fees paid will be fully refunded.
- The information on the form will only be used by Camp Kahquah for the specific purpose of providing your child with a memorable experience. I understand that this information will not be shared with any other group or used for any other purpose.
